## CIRCULAR

Sub:- TWD - Esst. - O/o DTW, AP., Hyd. - Transfer and postings by Counseling to the posts of Teachers in TW Ashram Schools, Tribal Welfare Primary Schools (Erstwhile GVVK Schools) and HWOs in Tribal Welfare Dept. - Arrangements for counseling -Instructions - issued -Reg.

Ref:- 1. G.O.Ms.No.53, SW (TW.Ser.III) Dept., Dt. 28-6-2005. 2. G.O,Ms.No.146 Fin (DCM-III) Dept dt.1-6-2012

In the G.Os cited, orders were issued by the Govt., to effect the transfers and postings to the post of Teachers/Hostel Welfare Officers working in Educational Institutions and Hostels etc. of Tribal Welfare Dept, by way of counseling as per G.O.Ms.No.53, SW (TW.Ser.III) Dept., Dt. 28-6-2005.

- 2. In the reference 2<sup>nd</sup> cited, Govt. have issued orders lifting of Ban on transfers for the year 2012-13 in two spells.
- 3. The Bye Elections in 12 districts are in process, the ban on transfers is relaxed in two spells as follows:
  - i) For all posts in the State in all the Districts where Bye-elections are now in process, w.e.f. 16<sup>th</sup> June, 2012 to 30<sup>th</sup> June, 2012.
  - ii) For all district level posts and below posts in all the Districts where no Bye elections are being held, w.e.f. 1st June 2012 to 15th June 2012.
- 4. Since Transfers Counseling has to be completed by **15-06-2012**, in the districts where no bye elections being held, all the Project Officer /Deputy Directors(TW) of ITDAs and District Tribal Welfare Officers of non-ITDA districts are requested to take immediate action as per the instructions issued hereunder so as to commence the counseling.
- 5. Further in all the Districts where Bye-elections are now in process, Transfers Counseling has to be completed by **30-6-2012** and all the Project

Officer /Deputy Directors(TW) of ITDAs and District Tribal Welfare Officers of non- ITDA districts are requested to take immediate action as per the instructions issued hereunder so as to commence the counseling.

- The application form for transfer shall be circulated to all institutions, in the offices of Project Officers/Deputy Directors (TW) ITDAs and District Tribal Welfare Officers of non- ITDA districts and wide publicity shall be given regarding transfer and it shall be displayed on notice board.
- 2. A receipt shall be given to the applicants acknowledging the receipt of application.
- 3. The details of application received shall be computerized.
- 4. The list of applicants that applied for the transfer will be arranged in the descending order, applicants with highest entitlement points at the top.
- 5. The list shall be prepared category-wise, subject wise and medium wise and shall be displayed on the notice board.
- 6. Transfer shall be considered only for clear vacant posts subject to requirement of each Ashram School.
- 7. The transfers of the employees in any cadre will not exceed more than 20%.
- 8. Counseling shall be taken up as per the Schedule given below.
