- 4. If four secondary grade teachers are working in the school and got transfer, the two junior in the school shall not be relieve without substitute
- 5. Like wise, if eleven secondary grade teachers are working in the school and got transfer, the six junior in the school shall not be relieve without substitute

The concerned HM of the High School/Mandal Educational officers concerned is requested to relieve the Teachers with instructions to report at his/her new station without fail.

The transfers orders now issued are subject to the condition that to outcome of SLP in the Hon'ble Supreme Court of India, New Delhi and other pending cases in Hon'ble courts.

The individuals are not eligible for TTA and joining time. He/She shall abide by the terms and conditions as stipulated by the Government and are liable for any action deemed to fit for violation if any..

The HM of the High School/Mandal Educational officer/ Dy.EO concerned is instructed to make necessary entries in Service Register of individual regarding the transfer/date of relief/date of joining..

The dates of relieve and joining should be reported promptly. Any violation of the said rules the Mandal Educational Officer & concerned Head Masters will be held responsible and disciplinary action will be taken against such Mandal Educational Officers and Head Masters as per CCA rules.
